

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to DemoFPS.com, and Demo LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Demo LLC include DemoFPS.com. The Demo LLC website is a Fingerprint site. By using the Demo LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information
